1 Identity of the administrator

The administrator decides on the purposes and methods of processing of personal data that the University processes, and it is Wroclaw University of Technology, based in Wroclaw at Wybrzezu Stanislaw Wyspiańskiego 27 - represented by the Rector. The administrator has appointed a Data Protection Officer (DPO), who can be contacted via email address: IOD@pwr.edu.pl. The DPO can be contacted on all matters relating to the processing of personal data.

2 Purposes of processing and legal basis for processing

Your personal data is processed in the controller's activities related to:

- 1. the preparation, organization and conduct of the International Robot Competition "XV Robotic Arena" in accordance with the Rules and Regulations, which the Participant accepts upon entering the event area, and the Competitor accepts when registering on the competition website, thereby entering into a participation agreement in accordance with Article 6.1. letter b (or letter c, as the case may be) of the DPA, the processing is either necessary for the conclusion of such agreement or necessary for the fulfillment of the controller's legal obligations;
- 2. the contacting of you (including to private addresses and/or the telephone number provided) for the purpose of communicating the administrator's information, decisions and orders and directing to you the administrator's offer remaining in connection with your status i.e. when it is necessary for the realization of the administrator's legitimate interests (Art. 6.1. lit. f. RODO).
- 3. the dissemination of your image in a photo, for the purpose of documentation of events, which includes: public sharing, capturing, processing, reproduction, archiving, storage and use of backup copies, publication, including in juxtaposition with images of other people (group photos) through any medium, including the Internet and in printed form.

3 Data recipients or categories of data recipients

Your personal data may be transferred to recipients such as: entities cooperating with the University as well as government administration bodies (especially the Ministry of Science and Higher Education) and other institutions cooperating, among others, in the implementation of public tasks

Recipients of the data may also be sponsors and institutions that finance or co-finance initiatives or projects implemented by the administrator. These institutions require the submission of reports on the administrator's activities including, among others, the university's cooperation with the environment. We will also make personal data concerning you available to auditors and

entities controlling the administrator's activities on the basis of the law or contracts concluded by the administrator.

Recipients of the data may also be other entities to which the administrator will order the performance of certain activities, which involve the necessity of processing personal data, e.g. entities providing services in the field of IT services, archiving, storage and destruction of documents protection of property and persons, postal and courier services, transportation services, etc. The University processes personal data using IT systems, public cloud, databases, hardware and software.

4 Data retention period

Data will be retained for the period necessary to fulfill the above-mentioned purposes, including with respect to data processing based on a legal obligation of the controller - for the period established by the provisions of the law in force at the time.

5 Rights of data subjects

You have the right to access and rectify the content of your data. You may exercise your rights to: request information about the data processed about you, request restriction of processing, you may request data portability, object on the grounds of your particular situation.
